#### **Operations**

- May 2022 Production Reports, Supt Gagnon reported the weather has been dry, so production has been picking up. Still in the middle of flushing, but about 2 million gallons less than last year. Productions expected to keep at this rate up until mid-September or October.
- Current Work:
  - Water Main Repairs
    - Route 88, there was a significant main break about 700 gallons a minute was leaking. The District was notified in late evening and it was taken care of right away. The repair went well.
    - Goodings End, there was a minor leak here. A connection to the main has a crack in it, and it was a quick fix.
    - Distribution Flushing, close to 60% complete.

- Sweetser Village Main Extension, this is the new 2 building 12-unit apartments, and it has been completed and is currently active.
- Tanglewood and Tannery Main Extension, the District worked with the Town as they updated the drainage here. Two dead end mains were connected and completed an important loop. It is now active and running.
- Supt Gagnon reported that the District received the vacuum unit and the operators have already put it to good use. It will be a valuable tool.
