#### **Old Business**

- North Yarmouth Select Board and Planning Board conversations: The letter the board sent was received and responded to well. More project specific conversations were had are upcoming to iron everything out.
- Solar Projects Update: Supt Gagnon reported that he signed the agreement with Chris Byers for Doughty Road.
  Right now, Supt Gagnon is getting everything together to get a proper number for what is needed for YWD solar
  before that application is filed. Chris and Supt Gagnon spoke about adding Gray Water District to the project and
  he said yes, just add more meters but it does add another owner to agreements, maintenance, their requirements,
  sizing, etc.
- 2023 Capital Projects Update: Pleasant St and Sunset Point are out to bid and are due on March 23rd. YWD needs to go in front of the Yarmouth planning board for Sunset Point to replace the piping due to the project being in the shoreland zone. The meeting for the planning board is set for April 12th.

#### **New Business**

- Meeting schedule conflict for April: Supt Gagnon asked the board to reschedule it to April 20th as the planning board meeting is scheduled for April 12th.
- Annual meeting schedule propose to have May meeting: Supt Gagnon proposed having the annual meeting in May because the auditors will have their reports done by May 10th. The board approved having the annual meeting May 10th followed by the regular monthly meeting.
- Trustee election: The board talking about Irving not re-running this upcoming election and those who have talked about running.

### **Operations**

- February 2023 Production Reports, Supt Gagnon reported everything was very calm and steady like the last few months. Production is slightly down from last year.
- Current Work
  - Monthly Hydrant Checks: everything is checking out.
  - Meter Replacements: 58 meter swaps were done in February.
  - Well Maintenance vibration analysis was done on all wells. There were a couple issues with the Steven's well. A larger discussion is to come with the cost analysis of what to do to get this well back up to par vs major replacement.
